





You can use logon triggers to audit and control server sessions, such as by tracking login activity, restricting logins to SQL Server, or limiting the number of sessions for a specific login.- Login auditing can be configured to write to the error log on the following events.- Failed logins- Successful logins- Both failed and successful loginsIncorrect:- C2 audit mode can be configured through SQL Server Management Studio or with the c2 audit mode option in sp_configure. Selecting this option will configure the server to record both failed and successful attempts to access statements and objects.
