Answer: Explanation:Note:- Create a new partitioned table with the partition function you want, and then insert the data from the old table into the new table by using an INSERT INTO...SELECT FROM statement.- SPLIT RANGE ( boundary\_value )Adds one partition to the partition function. boundary\_value determines the range of the new partition, and must differ from the existing boundary ranges of the partition function. Based on boundary\_value, the Database Engine splits one of the existing ranges into two. Of these two, the one where the new boundary\_value resides is considered the new partition.- BCP can be used to produce the zipped text file.- Example:plitting a partition of a partitioned table or index into two partitionsThe following example creates a partition function to partition a table or index into four partitions. ALTER PARTITION FUNCTION splits one of the partitions into two to create a total of five partitions.CREATE PARTITION FUNCTION myRangePF1 (int)AS RANGE LEFT FOR VALUES ( 1, 100, 1000 );GO--Split the partition between boundary\_values 100 and 1000--to create two partitions between boundary\_values 100 and 500 --and between boundary\_values 500 and 1000.ALTER PARTITION FUNCTION myRangePF1 () SPLIT RANGE (500);New QuestionDrag and Drop QuestionYou are planning to deploy a database to Windows Azure SQL Database.You need to design a stored procedure to update rows.
